RULES FOR STAGE USE

1. NO ALCOHOLIC BEVERAGES ARE ALLOWED.
2. SMOKING IS ALLOWED IN THE DESIGNATED AREAS WITH PROPER DISPOSAL OF BUTTS.
3. GOLF CARTS ARE PERMITTED BUT MUST YIELD TO PEDESTRIANS.
4. NO HORSES, UNLEASHED PETS, OR OTHER MOTORIZED VEHICLES ARE ALLOWED.
5. THE FACILITY SHOULD BE LEFT AS CLEAN AND IN AS GOOD A CONDITION AS IT WAS FOUND.
6. ALL TRASH AND PERISHABLE FOODS SHOULD BE REMOVED FROM THE AREA AND PROPERLY DISPOSED OF AFTER EACH USE.
7. NO EQUIPMENT IS TO BE REMOVED FROM THE AREA WITHOUT THE PRIOR APPROVAL OF THE TOWN COUNCIL.
8. ANY DECORATIONS SHOULD BE INSTALLED IN A MANNER THAT WILL NOT DAMAGE THE STRUCTURES AND SUCH DECORATIONS AND HANGING DEVICES SHOULD BE REMOVED AFTER USE.
9. RENTAL OF THE STAGE DOES NOT INCLUDE THE USE OF TOWN SUPPLIES.
10. THE FACILITIES WILL BE INSPECTED AFTER EACH USE AND PRIOR TO THE NEXT USE. IF ANY OF THE ABOVE RULES DO NOT PASS INSPECTION, FUTURE USE PRIVILEGES MAY BE REVOKED AND THE DEPOSIT MAY NOT BE REFUNDED.
